



Driving directions to 2019 tour homes

Note: Do not use the addresses in your GPS. They may not get you to the right location. New construction is not always picked up in maps. These directions are also based on coming from a main road. Please refer to the map if going in order, as you may be close to other homes.

Home 1 – Waverly Homes – Heritage Country Estates – 308 E. Spruce Avenue, La Center - From I-5 take exit 16 for La Center. Right on NW La Center Rd., continue onto NW Pacific Hwy. Right on West 4th Street. Continue to NE Lockwood Creek Road, left on East Spruce Avenue.

Homes 2 & 3 – New Tradition Homes and Kingston Homes – Cloverhill – 1291 S. 44th Avenue and 1269 S. 44th Avenue, Ridgefield - From I-5, take the Pioneer Street Exit (Exit 14) and go West. At the second traffic circle, turn left on S. 45th Avenue. Cloverhill will be on your right, just north of S. 15th St. **Note: If road construction is still taking place, use these directions** - I-5 North to Exit 14 Pioneer St., West to first traffic circle S. 56th Place, North at Timm Rd., West at S. 11th Street; Follow to stop sign at S. 44th Avenue; North 1 block to Cloverhill Community on west side of the street.

Home 4 – Generation Homes Northwest – Seven Wells Estates – 1236 S. 50th Place, Ridgefield - From I-5 North take Exit 14. Head West on Pioneer Street. Continue West to second traffic circle. At second circle, take the 3rd exit onto S. 45th Avenue. Left on Wells Drive and left on S. 50th Place into Seven Wells Estates Phase 4.

Home 5 – Evergreen Homes – Royal View – 3917 S. Hay Field Circle, Ridgefield - From I-5 North, Exit 14 (WA/501/Pioneer St.) and go left/west on Pioneer Street; at the second traffic circle, take the 3rd exit onto S. 45th Avenue which will turn into Royle Road; travel about 1.5 miles and Royal View will be on your left.

Home 6 – Romano Construction Services – Pioneer East – 1102 S. Quail Hill Place, Ridgefield – From I-5 North take Ridgefield Exit 14. Turn right off exit. Turn right at traffic circle, follow road around and take right at 259th Street and right on South 10th Street.

Home 7 – Holt Homes – Creekside Heights – 1219 NE 11th Avenue, Battle Ground - From I-5 North, use right 2 lanes to take exit 11 for WA-502E/NE 219th Street. Turn right onto WA-502. Turn left onto NW 20th Avenue. Turn right onto NW Onsdorff Blvd. Turn right onto NW 12th Avenue.

Home 8 – Affinity Homes – Meadows at Whipple Creek – 2301 NE 169th Circle, Ridgefield – From I-5, take the 179th Street Exit and head East. Continue on NE 179th St. to NE 26th Avenue. Follow NE 26th Avenue to NE 174th Street and follow to the right into development. Continue driving until you reach NE 169th Circle. Home will be on your left.

Home 9 – Ginn Homes – The Landing at Salmon Creek – 716 NW 138th St., Vancouver – From I-5 take exit 7B toward NE 139th St.; head West on NE 139th St.. Turn left on NW 7th Ave. to entrance of development.

Home 10 - David Weekley Homes – Heron Grove – 11507 NW 2nd Court, Vancouver - From I-5, take exit 5 and head west on NE 99th St. Drive 4 blocks and take a right on NE Hazel Dell Ave. and drive 0.7 miles. Turn left on NE 114th St., then turn right on NW 3rd Ave., and you will arrive at the Heron Grove community.

Home 11 – Pacific Lifestyle Homes – Amberglen – 6701 NE 119th Street, Vancouver - From I-205 take exit 32 onto NE Padden Parkway heading west. After 0.9 miles take a right onto NE Andresen Rd. Stay on NE Andresen Rd as it turns into NE 72nd Ave. in 0.4 miles. In 1.28 miles take a left onto NE 119th St. Home will be on the left.

Home 12 – Gecho Homes – Janssen Ridge – 8605 NE 39th Avenue, Vancouver - From I-5: Take the 78th Street exit. Go East on NE 78th Street. Take a left on NE 25th Ave. Take a right on NE 88th Street. Take a right on NE 39th Ave. From I-205: Take Padden Parkway exit, go west on Padden Parkway. Take a right on NE St. Johns Rd. Take a left at NE 88th Street. Take a left on NE 39th Ave.

Home 13 – New Tradition Homes – Ramey Lane – 16719 NE 97th St., Vancouver - Head East on Padden Parkway to NE 162nd Avenue. Left (North) on NE 162nd Avenue, right on NE 99th Street, and turn right on NE 168th Avenue.

Home 14– Pacific Lifestyle Homes – Adam’s Glen – 16701 NE 88th St., Vancouver - From I-205 take exit 32 onto NE Padden Parkway heading east. After 4 miles merge onto NE Ward Rd. After 0.4 Miles take a right onto NE 88th St. and Adam’s Glen will be on the right in 0.1 miles.

Homes 15-19 – Garrette Custom Homes, New Tradition Homes, Kingston Homes, Affinity Homes and Cascade West Development – Velvet Acres – 18907 NE 83rd Street, 18301 NE 82nd Street, 18303 NE 81st Street, 18402 NE 79th Street, and 18303 NE 79th Street, Vancouver - From NE 162nd Ave. & Padden Parkway go east on Ward Rd. Turn right onto NE 88th St. Follow the sharp corner onto NE 182nd Ave. and the community will be on your left.

Home 20 – Pacific Lifestyle Homes – Fishers Hollow – 814 NE 162nd Avenue, Vancouver - From I-205 take exit 28A for Mill Plain Blvd. and head east on Mill Plain Blvd. In 2.5 miles turn left on NE 164th Ave. In 0.9 miles, the community will be on your left.

Home 21 – Romano Construction Services – 2 Creeks – 3947 NW 75th Avenue, Camas - From WA-14, head North on NE 192nd Ave. Turn right onto NE 13th St. Continue onto NE Goodwin Rd. Turn right onto NW Alexandra Ln. at the Lacamas Heritage walking trailhead, proceed to gate and follow signs to home.

Home 22 – Cascade West Development – Lake Hills – 3125 NW Lake Place, Camas – From WA-14 head North on SE 192nd Ave. Turn right on Brady Rd., continue onto NW Parker Street, right on NW Lake Road, left on NW Lake Place.

Home 23 – Holt Homes – Windust Meadows – 1319 NE 37th Avenue, Camas - From WA-14 West, take exit toward NW 6th Avenue. At traffic circle, take the 2nd exit onto NW 6th Avenue. Turn right onto NE Garfield St. Turn left on NE 3rd Avenue. Turn left onto SE Crown Road. Turn left onto NE Woodburn Drive, turn left on NE Pioneer Street, turn left on NE 37th Avenue.

Home 24 – Urban NW Homes – Urban at Round Lake – 1754 NE 36th Avenue, Camas - From WA-14 West, take exit toward NW 6th Avenue. At traffic circle, take the 2nd exit onto NW 6th Avenue. Turn right onto NE Garfield St. Turn left on NE 3rd Avenue. Turn left onto SE Crown Road, then left onto NE Woodburn Dr., follow NE Woodburn Dr. to NE Pioneer St. and turn left. Take a right on NE 36th Avenue and the home will be on your left.

Home 25 – Holt Homes – Hills at Round Lake – 1748 NE Pecan Lane, Camas - From WA-14 West, take exit toward NW 6th Avenue. At traffic circle, take the 2nd exit onto NW 6th Avenue. Turn right onto NE Garfield St. Turn left on NE 3rd Avenue. Turn left onto SE Crown Road. Turn left onto NE Woodburn Drive. Turn left onto NE Tanoak Drive. Turn left onto NE Pecan Lane.
