



Permitting and inspections should remain uninterrupted by coronavirus

There is concern that Clark County and other jurisdictions are closing their building permit and inspection services. At this time most services are continuing as normal but there will most likely be changes coming. To stay up-to-date, [view our resources and closures page.](#)

Currently, staff and elected officials are discussing what systems to put in place to keep their staff and the public healthy and safe. They are creating contingency plans to avoid work slowdowns or stoppage. BIA staff and our partners have been in

contact with them since Friday, March 13 and are working to make sure they are aware of industry concerns. We are also being proactive in offering possible solutions to slowdown and stoppages, should they occur.

Ridgefield: A Song of Signs and Garages

Two issues recently arose in Ridgefield that has caused concern for our members: a ban on directional sign placement and enforcement of a 4' garage setback code. Fortunately, we have been able to work with city staff to address these issues.

Recently, a city staff member told builders that the directional signs used to increase sales traffic are in violation of code. They are, generally, not. However, there are two prohibitions to be aware of: Signs are not allowed in the state highway system right-of-way, so do not place on Pioneer Street. They also not be placed in a hazardous manner, e.g. impeding line of site for traffic. City Manager Steve Stuart is working with staff to make sure they are properly interpreting and applying the nuisance sign code.

Staff recently let builders know that they must comply with a 4' garage setback code or they would be denied a building permit. Although this law has been on the books for quite a while, it had not been enforced until last week. No notice was given to our industry. Once again, working with Mr. Stuart, we have negotiated a temporary reprieve to enforcement of this code and are working with Mr. Stuart and his staff to find short and long term solutions that will support the desires of city council while also allowing our builders to continue building the beautiful projects that city wants to encourage.

Due to the ongoing health concerns, the Stronger Vancouver discussions have been suspended.

Legislative Update: Sine Die "End of Session"

The legislature recently wrapped-up and we are still trying to get our arms around everything that did and didn't happen; the good and the bad. We will be sending out a special edition post-session wrap-up notice the week of March 30 so be sure to keep an eye out. A few things we do know:

Good:

- [HB 2673](#) – Expanded categorical SEPA exemption for infill – **on Governor's desk**
- [HB 1395](#) – Direct contractor liability – **did not pass**
- [HB 2564](#) – Mandatory 10 hr off site training for construction workers – **did not pass**
- [SB 6053](#) – Personal property liens for contractors – **did not pass**

Bad:

- [HB 2894](#) – Eliminate double taxation on concrete pumping – **did not pass**

Ugly:

- [HB 2267](#) – Energy code update delay - **did not pass**
- [HB 6492](#) – Increased "service" sector B&O tax (+.25%) – **signed into law**

The good and bad ideas that died this year will most likely be filed again next year, and you can do something about it.

WSU Vancouver Mentor Alliance Program helps businesses grow

Education very often becomes a two-way street, with educators and students learning from one another. The WSU Vancouver Mentor Alliance Program emulates this idea and allows students, faculty, and business owners to learn from each other in a collaborative way.

This program has already provided \$15 million dollars in revenue for local small businesses and has provided over 109,000 hours of free consulting to small businesses. Students and faculty work in a symbiotic way to consult small businesses who are in the early stages of growing their businesses. Not only does this give students real world experience, but small business owners get free business consultations with both WSUV faculty and students.

The Mentor Alliance Program also holds a meeting once a month. It invites small business owners, students, faculty, and the general public to come and discuss the latest

business practices and strategies for growing small businesses in our region.

The program aims to pair students with local business owners who have been in business for 3-5 years. Businesses that are accepted to the program must invest a minimum of 12 hours over a 16-week semester. Not only does this educate students on entrepreneurship but gives each business 500 hours of free consulting with WSUV faculty and students, helping your business grow. The program is confidential and at the same time allows small business to connect with the local community.

Study Shows Nearly 800 Households Priced Out of Vancouver Housing Market with Each \$1,000 Price Increase

According to a study by NAHB, a \$1,000 increase in the cost of a median-priced newly-built homes in Vancouver pushes 781 prospective buyers out of the market.

This study illustrates how even a relatively small increase in price or interest rates can dramatically impact housing affordability. Housing affordability has reached crisis status in communities across our state. Rising interest rates, regulatory barriers, higher building materials costs and labor shortages all add to the cost of a home, and are preventing households from achieving the goal of homeownership.

According to the NAHB study, the median price of a home in the

Vancouver and Portland area is \$499,279. Although the amount of a physical home is less expensive than the Seattle, Tacoma, and Bellevue area, the home prices are the third highest in the state and continue to rise due to permits and fees.

As legislators convene in Olympia, they need to understand that by adding layers of regulation, taxes and fees, you cannot make housing more affordable. Over 25% of the cost of a new home nationally is the result of government regulation and does not include regulations imposed at the state and local level here in Washington.

Congress Expected to Pass Coronavirus Response Act Requiring Employer-Paid Sick and Medical Leave

On Friday, the House passed H.R. 6201, the Family First Coronavirus Response Act, which would guarantee free coronavirus testing, establish paid leave for all employees, enhance unemployment insurance, expand food security initiatives and increase federal Medicaid funding. The Senate is expected to pass the bill in the coming days, and President Trump has indicated his support for the legislation. [READ MORE.](#)


