



## Driving directions to 2020 tour homes

*Note: Do not use the addresses in your GPS. They may not get you to the right location. New construction is not always picked up in maps. These directions are also based on coming from a main road. Please refer to the map if going in order, as you may be close to other homes.*

**Home 1 – Krippner Homes – Union Ridge Ranch – 2208 N 4<sup>th</sup> Way, Ridgefield** – From I-5 North or I-5 South, take Exit 14 for Pioneer Street/WA-501 in Ridgefield. Turn west on WA-501/Pioneer St. and continue west through three roundabouts. Turn Right on N. Reiman Road. Turn left on N. 5<sup>th</sup> Way. Turn left onto N. 23<sup>rd</sup> Place. Then take a right on N. 4<sup>th</sup> Way. The house is the 3<sup>rd</sup> one on the right.

**Home 2 – Kingston Homes – Cloverhill – 4210 S 16<sup>th</sup> Way, Ridgefield** - From I-5 North or I-5 South, take Exit 14, west on Pioneer to Royle Road. Turn south on Royle Road for 1/2 mile to S. 15<sup>th</sup> Street. Take immediate turn into subdivision on S. 43<sup>rd</sup> Place. First house on the right.

**Home 3 – Evergreen Homes NW – Royal View – 4026 S Hay Field Circle, Ridgefield** - From I-5 North or I-5 South, take Exit 14 and turn left onto Pioneer St.; at the first roundabout, take the 1<sup>st</sup> exit on Pioneer St; at the 2nd roundabout, take the 3<sup>rd</sup> exit on S. 45<sup>th</sup> Ave; at the 3rd roundabout take the 1<sup>st</sup> exit onto S. Royle Rd; go 1.2 miles and at S. Hay Field Circle, turn left into Royal View; follow the road through the curve and the home will be on your left.

**Home 4 – Holt Homes – Teal Crest – 1323 S Sevier Rd., Ridgefield** – From I-5 North or I-5 South, take Exit 14 and head west on Pioneer St. to S. Royle Rd. Head south on S. Royle Rd. Turn right on S. Hillhurst Rd. Turn left on S. Sevier Rd. Follow S. Sevier Rd. until you reach Teal Crest. The house will be on the left.

**Home 5 – Urban NW Homes – The Cedars by Urban – 4008 SE 19<sup>th</sup> Ave., Brush Prairie** - From I-5 N or I-205 N, take WA-500 E to NE Padden Parkway. Turn right on NE Padden Parkway, turn left on NE 152<sup>nd</sup> Ave, turn left on NE 181<sup>st</sup> St., then turn left onto SE 19<sup>th</sup> Ave. Model home will be on your right.

**Home 6 – Richmond American Homes – Seasons at Moonlight – 12331 NE 114<sup>th</sup> St., Vancouver** – From I-205, merge onto WA-500 East. Continue onto NE 117<sup>th</sup> Ave., then turn right onto NE 113<sup>th</sup> St. Turn left onto NE 122<sup>nd</sup> Ave., then right onto NE 114<sup>th</sup> St. Model home will be on your right.

**Home 7 – Quail Homes – Model Home at Club Green Meadows – 7909 NE 78<sup>th</sup> St., Vancouver** – From I-205 South, take Exit 32. Turn left on NE Andresen Rd., turn left (East) on NE 78<sup>th</sup> Street. Follow for 1/4 mile. Home is on the right across from Crossroads Church.

**Home 8 – Songbird Homes – Kestrel Field – 10205 NE 63<sup>rd</sup> Pl. Vancouver** (GPS friendly address 6311 NE 102<sup>nd</sup> Ave.) From I-205 South: take Exit 32. Turn left on NE Padden Parkway, right (south) on NE 94<sup>th</sup> Avenue, right (south) on NE Covington Road, right on NE 102<sup>nd</sup> Avenue.

From WA-500: north on Gher Road, continue on NE Covington Road, left on NE 63<sup>rd</sup> Street, right on NE 102<sup>nd</sup> Avenue.

**Homes 9 and 10 – Affinity Homes and MC Custom Homes – Dawson’s Ridge – 4425 NW Paddock Ln., 526 NW Dawson Ridge Dr., Camas** - From WA-14, take Exit 10 at SE 192<sup>nd</sup> Ave. Head north on SE 192<sup>nd</sup> Ave. Head east on NW Brady Road. Turn right on NW McIntosh Rd. Take the first right onto NW Dawson Ridge Drive.

**Home 11 – Genesis Homes NW – Summit Terrace – 1924 NW 33<sup>rd</sup> Way, Camas** – From WA-14, take Exit 10 at SE 192<sup>nd</sup> Avenue. Go east on SE 20<sup>th</sup> Street, this becomes NW 38<sup>th</sup> Avenue. Turn right on NW Dahlia Dr., becomes NW 29<sup>th</sup> Avenue, then NW Valley Street. Turn right on NW 33<sup>rd</sup> Way.
