



## Driving directions to 2021 tour homes

*Note: Do not use the addresses in your GPS. They may not get you to the right location. New construction is not always picked up in maps. These directions are also based on coming from a main road. Please refer to the map if going in order, as you may be close to other homes.*

**Home 1 – Evergreen Homes NW – Royal View – 4023 S Hay Field Circle, Ridgefield** - From I-5 North, take Exit 14 and turn left onto WA-501/Pioneer St.; at the first roundabout, take the 1<sup>st</sup> exit on Pioneer St; at the 2nd roundabout, take the 3<sup>rd</sup> exit on S. 45<sup>th</sup> Ave; at the 3rd roundabout take the 1<sup>st</sup> exit onto S. Royle Rd; go 1.2 miles and at S. Hay Field Circle, turn left into Royal View; follow the road through the curve and the home will be on your right.

**Home 2 – Richmond American Homes – Seasons at Kemper Loop – 565 N 32<sup>nd</sup> Court, Ridgefield** – From I-5 North or I-5 South, take Exit 14 toward Ridgefield. Turn West on WA-501/Pioneer Street. Continue on Pioneer Street. At the third roundabout, take the first exit onto N. 35th Avenue. Turn left on N. Pioneer Canyon Drive, then right on N. 32nd Court. Community is ahead on the left.

**Home 3 – Urban NW Homes – Urban Downs – 912 S 88<sup>th</sup> Avenue, Ridgefield** - From I-5 North or I-5 South, take Exit 11 for WA-502, turn left on NE 10th Avenue, then right onto NE 259th Street, turn left into Urban Downs community on S. 88th Avenue. Model home will be first home on your right.

**Home 4 – Generation Homes NW – Cedar Landing – 2704 SE 25<sup>th</sup> Avenue, Battle Ground** - Head North on Highway 503 to SW Eaton Blvd., turn right on SW Eaton Blvd., right on NE 157th Avenue, (which turns to SE 25th Avenue). Home is on right.

**Home 5 – Summerplace Homes – Larkspur – 6325 NW Lambert Lane, Camas** – From WA-14 East, take Exit 10 onto SE 192nd Avenue. Head North on SE 192<sup>nd</sup> Avenue until SE 1st Street. Take a right on SE 1st Street (which becomes Lake Road) and continue East, turn left onto NW Larkspur Street. Head down the hill and take the next left onto NW McMaster Drive. Then the next left on NW Lambert Lane and continue to the Cul de Sac where the home is located.

**Home 6 – Affinity Homes – The Parklands at Camas Meadows – 3428 NW McMaster Drive, Camas** – From WA-14 East, take Exit 10 onto SE 192nd Avenue. Head North on SE 192<sup>nd</sup> Avenue until SE 1st Street. Take a right on SE 1st Street (becomes Lake Road) and continue East, turn left onto NW Larkspur Street, follow to NW Camas Meadows Drive. Turn right on NW McMaster Drive and follow to home on the right.

**Home 7 – Richmond American Homes – Magnolia Heights – 901 W. Magnolia Loop, Washougal** - From WA-14 East, take Exit 12 toward Camas. At the roundabout, take the second exit onto NW 6th Avenue. Turn right on NE Adams Street. Left on NE 3rd Avenue, then left on SE Crown Road. Proceed up the hill and turn right on W. Fir Court. Model home is on the right.
